

## VC-111342 **COMMERCIAL LIMITED WARRANT**

7 Year Limited Warranty for Commercial applications for all products beginning with VE is extended to the original consumer where the Vista Solar Control Window Film was installed and is not transferable.
10 Year Limited Warranty for Commercial applications for V40SRCDF, V50SRCDF, VS60SRCDF, VS61SRCDF, VS70SRCDF and VS75SRCDF is extended to the original consumer where the Vista Solar Control Window Film was installed and is not transferable.
15 Year Limited Warranty for Commercial applications for V14SRCDF, V18SRCDF, V28SRCDF, V33SRCDF, V33BSRCDF, V38SRCDF, V48SRCDF, V48SRCDF and V58SRCDF is extended to the original consumer where the Vista Solar Control Window Film was installed and is not transferable.
NOTE: VS60SRCDF and VS70SRCDF require the use of the Spectra Seal application to be valid.

Vista Solar Control Window Film is warranted against crazing, peeling, demetallizing, bubbling, delaminating or discoloring when properly installed according to the manufacturer's film to glass recommendations on suitable interior surfaces of glass windows by a duly authorized dealer. If the film fails to comply with the warranty, the manufacturer will replace the non-conforming or defective film (labor & materials) at no cost to the consumer.

The manufacturer also warrants against failure of the glass described herein due to:

Seal Failure for a period of thirty-six (36) months if covered by original sealed unit manufacturer. Due to a wide variety of compounds used, no warranty coverage is provided for window "backbedding sealants".

Thermal Shock Fracture for a period of sixty (60) months from the original completion date of the manufacturer's film installation to the glass. The replacement cost is limited to a value up to U.S. \$500 per window of said glass caused as a direct result of the application of the Vista Solar Control Window Film. There is a deductible of \$25.00 (U.S. \$) or 5% of the replacement cost, whichever is greater, for small commercial installations. The deductible for commercial installations over 2,500 sq. ft. is \$100.00 (U.S.\$) or 5% of the replacement cost, whichever is greater.

Any owner desiring warranty service on any product covered by this limited warranty should, provide the information contained in the installation record or bill of sale furnished at the time of purchase, together with a description of the specific defect and send it to the authorized dealer from which the film was originally purchased or to CPFilms Inc., Warranty Services, Post Office Box 5068, Martinsville, Virginia, 24115. Proof of purchase is also required in order to obtain warranty coverage. It is therefore recommended that the purchaser retain the completed installation record or sales receipt and a copy of the warranty.

Manufacturer's/CPFilms' sole obligation to the owner/purchaser, whether claim be based in contract, negligence, tort or otherwise, shall be solely as provided hereunder and damages and remedies shall be as provided hereunder.

EXCEPT DURING THE APPLICABLE LIMITED WARRANTY PERIOD SET FORTH ABOVE, CPFIIms Inc., HEREBY EXCLUDES AND DISCLAIMS ANY AND ALL OTHER EXPRESS OR IMPLIED WARRANTIES, INCLUDING THE WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

Some States/Provinces do not allow the exclusion or limitation of incidental or consequential damages or limitations on how long an implied warranty lasts, so the above limitations may not apply to you. This warranty gives you specific legal rights and you may also have other rights that vary from State/Province to State/Province.

This warranty is void if the film is subject to abuse or improper care. The manufacturer assumes no liability for scratching or damaging of the film by improper treatment.

This limited warranty or any part of it is void only where expressly prohibited by law. VISTA Solar Control Window Film is not warranted in any way, except as expressly stated in this limited warranty and operation of law.

## Window Care

- To ensure long life and maximum serviceability from Vista Window Film, DO NOT WASH FOR THIRTY (30) DAYS AFTER INSTALLATION.
- When cleaning, use a soft cloth or clean synthetic sponge. Use a soft cloth or squeegee for drying the window. Use common cleaning solutions which do not contain abrasive materials.
- After installation, there may be a hazy appearance. This condition is temporary, caused by the moisture used in applying the film. After this moisture dries, the hazy condition will disappear.
